Thanks very much for providing this information. I'm tracking the various time transfers between JWST GTO teams, and I have a couple of questions for you.

I did not previously have a record of the MIRI contribution to program 1189. I'll add that record now, but there are 8 GTOs who own MIRI time: George Rieke, Tom Greene, Margaret Meixner, Mike Ressler, Christine Chen, Scott Friedman, Karl Gordon, and Gillian Wright. Can you please tell me which of these MIRI GTO time owners is contributing to program 1189?

I have been working with Pierre-Olivier Lagage for the MIRI GTO observations of the Y dwarf program. Pierre-Olivier has been given this time from Gillian Wright.

I currently have a record (see attached email from Maria Rieke) that indicates a 1.8 contribution of NIRSpec time from Pierre Ferruit to program 1189. Is that contribution no longer applicable? If not, I'll transfer that 1.8 hours back to Pierre. That is correct, NIRSpec is no longer contributing time to Program 1189

There have been a couple tweaks to 1189 from the consortium members and are reflected in the latest upload to APT. The revised time accounting is:
